## Instructions for student discipline in institutions Ministry of Higher Education and Scientific Research No. 160 of 2007

Article 1:

The student is committed to the following:

First: Compliance with internal laws and regulations, instructions and orders issued by the Ministry Higher Education and Scientific Research and its Institutions (University - Faculty - College – Institute)

Second - not to prejudice religious beliefs or national feelings or national bad or

Intentionally stirring up sectarian, ethnic or religious strife Third - Not to harm the reputation of the ministry or its institutions by word or deed within it or Outside.

Third- Avoid all that is contrary to university behavior of high discipline and respect for management Faculty, staff, fellowships and cooperation among students.

Fifth - the proper disciplined behavior that will affect positively upon nomination and nomination For scholarships and fellowships.

Sixth - To refrain from any action that disrupts the order and tranquility and tranquility within Campus or participating in it and inciting it or covering up its sponsors.

Seventh - Preserving the requirements of the university and college.

Eighth - Not to disturb the good conduct of the study in the college.

Ninth - The restriction on the uniform uniform for the students, taking into account the specificity of each university Or college.

Tenth - Avoid calling for organizations to deepen discrimination or practice any A category of political, religious or social persecution.

Eleventh- Avoid publicity for any political party, organization or group National or sectarian, whether it be in the suspension of pictures or signs, posters or establishment Seminars.

Twelves'- Do not invite party figures to give lectures or hold party seminars Or religious propaganda on campus to preserve national unity.

Article 2-

The student shall be punished by warning if he commits any of the following offenses:

First: Non-compliance with uniform uniform at the university.

Second - bad relations to the fellowship among students or beyond by saying to one of the students.

Article 3-

The student shall be punished by warning if he commits any of the following offenses:

The first - actually requires the punishment of the alert with already punished by the penalty of alert.

Second - disruption of the system and tranquility and tranquility in the university or college.

Article 4

The student shall be punished by dismissal for thirty (30) days if he commits an offense Next:

First - an act that requires the punishment of the warning with already punished by the penalty of warning.

Second - Overstepping him by saying one of the university employees who are not members of the faculty.

Third - Defamation of a member of the teaching staff, which harms him or her within the college Outside.

Fourthly - placing stickers) on campus that disturb public order And literature).

Article 5 -

The student shall be punished by temporary dismissal from the university for a period not exceeding one academic year If he commits any of the following offenses:

(1) If it is repeated as one of the acts stipulated in Article (4) of this Instructions.

Second - March or incite sectarian, ethnic or political groupings or Party on campus.

Thirdly - he has already assaulted a member of the university who is not a faculty member.

Fourth- Use violence against fellow students.

Fifth- Threat of armed violence.

Sixth - Carrying all types of weapons on leave or without permission within the campus.

Seventh- intentionally or grossly causing damage to the property of the university or college;

Eighth - his abuse of national unity or religious beliefs.

Ninth- Tazazoh by saying one of the faculty members within the college or Outside.

Tenth- Abuse of the university's reputation by word or deed.

Eleventh- Deliberate violation of the good conduct of the study.

Twelve - proved the commission of fraud and fraud on fellow students and faculty members.

Article 6:

The student shall be punished by the final dismissal of a college and by a decision of the university and shall be registered if he commits

One of the following offenses:

First - Repeating one of the offenses stipulated in Article 5 of these Instructions.

Second, he is already assaulting a faculty member or lecturers at the university.

Third, it is a disgraceful act and contrary to morality and public morals.

Fourth- Submit any forged documents or books or documents knowing that they are forged or Being a instigator of counterfeiting.

Fifthly - the perpetration of an act that violates security and tranquility on the campus or Subscribe to it or help it.

Sixth - When he is convicted of a felony or misdemeanor offense, the duration of his sentence is increased

- Article 7:

First, the penalties stipulated in Articles (2), (3) and (4) shall not be prohibited

(5) and (6) of these instructions to the offending student, to impose other penalties

If the violation occurred under penalty of penal laws. Second - If a criminal action is brought against the student for an act attributed to him outside the university It will be subject to disciplinary consideration until a decision is taken on the criminal case.

Article 8:

The Dean of the College is the Student Discipline Committee headed by the Dean's Assistant and the membership of two of them The members of the faculty should be a member of the committee legally and a representative of a union (Elect) and assigns an administrative officer to the work of the Committee.

Article 9:

No disciplinary punishment may be imposed unless it is recommended by the Disciplinary Committee.

Article 10 -

The disciplinary penalties provided for in these instructions shall be imposed by a decision of the Board And the Council may delegate its powers to the Dean of the College.

Article 11 -

First - the punishment of warning and warning is categorical.

Second - for students dismissed from the College for a period not exceeding thirty (30) days of objection

Third- The decision of dismissal at the College Council and the decision is final. A student who is dismissed from college for a period not exceeding thirty (30) days of objection The decision of the dismissal of the President of the University and his decision is absolute.

Fourth: Students who have been dismissed from the College shall have a final chapter on the objection to the dismissal decision

To the University Council and its decision is final.

Article 12:

Students may object to the dismissal decisions provided for in Articles II and II

(Iii) and (iv) of Article (11) of these instructions within (7) days of The date of notification of the decision against him, the failure to be informed he has the right to object during (15) Fifteen days from the date of publication of the decision of dismissal in the notice board.

Article 13 -

The decision of the penalty shall be placed on the notice board at the college for a term of not less than (15) years Ten days and informs the student's guardian in writing.

Article 14 -

Instructions for the discipline of students of higher education No. (19) for the year 1989 shall be repealed.

Article 15 -

These instructions shall be implemented from the date of their publication.

## **Important Instructions for Students:**

1. The student must abide by the instructions and instructions issued by the college

2. Follow the bulletin board and see what is attached to the instructions and instructions

3. Obligation to wear uniform uniform determined by the Deanship of the College to maintain the university appearance
