VII / Powers of the College Council (Institute)

The College Council exercises the following powers to conduct the work of the College and achieve its objectives:

VII / 1: Scientific powers

- 1. Drawing the college policy in line with the general policy of the university and achieving its mission.
- 2. Preparation of acceptance plans for undergraduate and graduate studies in the departments of the college.
- 3. Preparation of the scientific research plan and the authoring and translation of the departments of the college.
- 4. Recommending the creation, integration or cancellation of scientific divisions or branches.
- 5. Recommending the development of postgraduate studies in the college.
- 6. Consideration of the plans of the scientific sections on inviting visiting professors, conferences, scientific symposiums, scholarships, scientific assignments, visas and leave inside and outside the country, and recommending them to the Rector to obtain approval.
- 7. Approving the titles of letters and papers for postgraduate studies and approving the naming of supervisors for graduate students and naming the members of the discussion committees.
- 8. Name members of the comprehensive examination committees for doctoral students.
- 9. Reviewing the curricula of graduate and primary studies periodically and distributing them to the academic stages.
- 10. Approval of the results of the postgraduate and primary examinations after being submitted by the departments and scientific branches in the college.
- 11. Approval of the final examination schedules after graduation from the departments and scientific branches.
- 12. Recommending the scientific promotion of the faculty member (teacher and assistant professor) and submitting them to the university to issue the university order.
- 13. Recommending the lifting of the promotion of the faculty member to the rank of professor to the Central Committee for Scientific Promotion at the University, which in turn will complete its legal proceedings and then submit them to the President of the University for submission to the University Council.
- 14. Approve the postponement of the academic year of the College students after the availability of justified justifications and documents required for the first time, and recommending the postponement for the second time.
- 15. Approval of the first extension of graduate students (6 six months) and the recommendation of the Council of the Department.
- 16. Recommending to the Rector the approval of the second and third extension of postgraduate students on the proposal of the Council of the Department or the scientific branch in the College.
- 17. Recommending borrowing the services of teaching staff members and

lecturers for postgraduate studies as needed and the period specified by the departments and branches.

- 18. Proposing scientific and cultural agreements with the corresponding colleges inside and outside the country and submitting them to the university for approval.
- 19. Recommending to the President of the University the granting of scientific certificates to graduates in the preliminary and higher studies of all the specialties in the university.

VII / 2: Administrative Powers

- 1. Preparing the college staff for the next academic year in the second half of the current academic year in light of the proposal of the Dean and the sections and branches councils.
- 2. The beneficiary of the change of addresses of technicians and administrators within the authorized owners of the college.
- 3. Review the faculty of the College periodically.
- 4. Forming committees to assist him in performing his scientific, administrative and educational tasks.
- 5. Disciplinary penalties imposed on students.
- 6. Recommend the punishment of teachers and employees of one of the penalties for violating laws and regulations in force.
- 7. Recommending the abolition of sanctions imposed on teachers and staff after the exhaustion of their purposes.
- 8. Recommend referral of any of the faculty members to the competent courts as a result of their violation of the provisions of the law.
- 9. Recommend the extension of the teaching staff (professor, assistant professor) when they reach the legal age of one year and renewed for a maximum of three times.
- 10. Approve the acceptance of medical reports issued from outside Iraq to all members of the College, provided that such reports comply with the regulations and provisions contained in the sick leave system No. 76 of 1959 and its amendments.

VII / 3: Financial Powers

- 1. Proposing the annual budget plan, the import plan and the investment plan of the college, and submitting it to the university president for unification with the plans of the colleges and other institutes and submitting them to the university council for approval.
- 2. Recommending to the university to approve the final accounts of the college.
- 3. Review the report of the Financial Control Bureau of the College and discuss it and express opinion in the observations contained therein.
- 4. The authority to distribute the required financial allocations between the scientific departments and in coordination with the heads of scientific departments.
- 5. Authorization of the dean of the college or institute some powers
